



Claim Your Toll-Refunds

Since 2009, the Federal Republic of Germany has been charging transport companies too much for truck tolls. For the third time, the federal government has been certified by a court that the requirements of the European Road Costs Directive are not being complied with. In its ruling of March 20, 2024 (case number 14 K 6556/20), the Cologne Administrative Court ruled that police costs were also illegally included in the cost calculation of the toll in the years 2015-2020 and that this toll share of 5.86 or 4.44% of the infrastructure costs must be refunded to toll payers. Previously, the European Court of Justice in a decision of October 28, 2020 (case number C-321/19) and the Münster Higher Administrative Court in its judgment of November 30, 2021 (case number 9 A 118/16) had collected parts of the toll for previous periods and awarded the plaintiffs refunds totaling up to 12.8% (including interest).

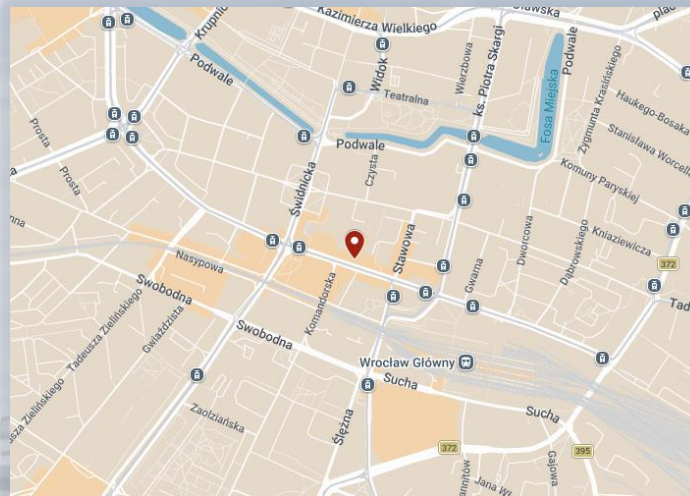
